Consider public safety and security matters, including installation, operation, and maintenance of public safety and security devices and services; amendment to rules regarding use of District parks and open space; contracting with security and/or licensed peace officers for supplemental law enforcement services; and authorize actions to effectuate such matters, including approval of agreement for monthly maintenance and monitoring of security devices.
3. District Management Structure Committee report on recommendations for future District management and taking of appropriate actions, including contracting with General Manager.
4. Review, approve and authorize execution of Agreement(s) for Use of Facilities received throughout the month.
5. Consider request from Euless Fire Department for permission to use District lake for water rescue training and recertification on water rescues.
